

Pursuant to Section Section 314(a)(1), of the Coronavirus Response and Relief Supplemental Appropriations Act, 2021 (CRRSAA) participating institutions must post certain information on the institution's primary website. This is a summary of all funds made available to students in accordance with CRRSAA as of May 31, 2021. In accordance with the CRRSAA, New England Institute of Technology (NEIT) posts the following information:

- 1. An acknowledgement that the institution received a grant under Section 314(d)(5) of the CRRSAA requiring the institution to provide at least the same amount of funding in financial aid grants to students as was required to be provided under sections 18004(a)(1) of the Coronavirus Aid, Relief, and Economic Security Act (CARES Act). The institution must make financial aid grants to students which may be used for any cost of attendance or for emergency costs that arise due to coronavirus and the institution will prioritize grants to students of exceptional need.
 - NEIT's Response: On March 10, 2021 New England Institute of Technology received a grant to make funds available to students and that the institution will prioritize grants to students with exceptional need.
- 2. The total amount of funds that the institution will receive or has received from the Department pursuant to the institution's Certification and Agreement [for] Emergency Financial Aid Grants to Students under CRRSAA.
 - NEIT's Response: The institution was awarded \$1,838,021 to be distributed to students under the Emergency Financial Aid Grant to Students.
- 3. The total amount of Emergency Financial Aid Grants distributed to students under Section 314 of the CRRSAA as of the date of submission (i.e., as of the 30-day Report and every 45 days thereafter).
 - NEIT's Response: As of May 31, 2021, \$1,838,021 of funds have been distributed to students under Section 314 of CRRSAA.
- 4. The total number of students who were eligible and received an Emergency Financial Aid Grant under Section 314 of the CRRSAA.
 - NEIT's Response: 2,045 students were eligible and received Emergency Financial Aid Grants as of May 31, 2021.
- 5. The method(s) used by the institution to determine which students receive Emergency Financial Aid Grants and how much they would receive under Section 314 of CRRSSA.
 - NEIT's Response: The institution identified all enrolled students at the school during the winter term shortly before the school was awarded the grant. We then excluded the students that were non-matriculating students, continuing-ed students and students with less than 4 credit hours for

- the term. All Pell eligible students received a grant of \$1,100 while non-Pell students received a grant of \$800. The institution then gave \$530 to new students enrolled for the Spring quarter.
- 6. Any instructions, directions, or guidance provided by the institution to students concerning the Emergency Financial Aid Grants
 - NEIT's Response: NEIT has e-mailed formal instructions on a letter describing the Emergency Financial Aid Grant to all eligible students with information on how to contact Financial Aid should they have any specific questions.
